Introduction

Integer Wealth Global is a British and European based, purpose specific financial product and services management company providing oversight, policy, direction, and strategic implementation management for its member companies who provide local and international facilitation of forensic due diligence, investment prospectus compilation, project investment and funding and stock exchange listings advisory services.

The core function of the company is the origination and facilitation of investment into credible and bespoke projects and opportunities through alternative investment vehicles to medium term real estate, commercial and industrial development, production, energy and innovative technology projects and revenue generating acquisitions through either direct investment or through listed alternative investment vehicle structures.

The objective of the company is the growth of our asset, equity and monetary value base for the benefit of our shareholders, investors, management and staff. The company also employs a generous staff equity program as also a corporate social responsibility program.

Integer Wealth Global has reformatted its operations and aligned its vision cohesively to its development and scaling trajectory.

Executive management and the board decided to restructure the company in early 2019 to place each of its member companies under a single umbrella company being Integer Wealth Global, for the specific intent to create equity and monetary value through service excellence within the company.

From a single company, originally ‘Integer Wealth Limited’, the company which originally provided corporate and business funding and investment along with its required risk management, audit and business services, the company grew in capacity to deliver ever more specialised products and services.

Consequently, the management and board decided to separate the functions of the original company which had developed robust separately grouped revenue streams, creating sufficient value to be managed separately under separate registered company entities, and so the oversight and management ‘umbrella’ company ‘Integer Wealth Global Ltd’ was born.

Each member company is intrinsically linked to the other through intercompany engagement, collaboration, and shared resources, enjoying the services from each other to collectively grow the holding company’s value.
